I understand that the risks include bodily injury that may lead to permanent disability or death.

Waiver.

I waive any and all claims that I have or may have in the future against R5V, Colorado Fast Food Products, LLC, and any other associated Landlords or 3rd parties, and their successors or assigns.

Release.

I release R5V, Colorado Fast Food Products, LLC, and other associated Landlords or 3rd parties and their officers, agents, and employees from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer, as a result of my participation in the Activities, use of the R5V equipment, or any other cause whatsoever, including negligence or breach of contract by R5V.

Rules.
